Liability waiver (please read)

In consideration of Wolverine Paintball furnishing services and/or equipment to enable me to participate in Paintball games, I agree as follows.... I fully understand and acknowledge that; (a) risks and dangers exist in my use of Paintball equipment and my participation in Paintball activities; (b) my participation in such activities and/or use of such equipment may result in my injury or illness including but not limited to bodily injury ,disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, animal bites or stings, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, landlords, employees, officers or agents of Wolverine Paintball; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees of Wolverine Paintball, or by any other person

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Wolverine paintball and it's owners, property owners, agents, officers and employees from any and all claims, actions or losses for bodily injury, property damage, wrongful death, loss of services or otherwise which may arise out of my use of Paintball equipment or my participation in Paintball activities. I specifically understand that I am releasing, discharging and waiving any claims or actions that I may have presently or in the future for the negligent acts or other conduct by the owners, property owners, agents, officers or employees of Wolverine Paintball. This waiver is valid through year end.

MEDICAL PERMISSION AUTHORIZATION..... If the participant is of minority age, the undersigned parent or guardian hereby gives permission for Wolverine Paintball to authorize emergency medical treatment as may be deemed necessary for the child named below while participating in Paintball games.

I WILL FOLLOW ALL FIELD RULES AS WELL AS OBEY ALL REF CALLS AND DECISIONS. I UNDERSTAND THAT I AM RESPONSIBLE FOR LOSS OR DAMAGE TO EQUIPMENT I RENT OR USE OR FOR ANY DAMAGES CAUSED BY ME. I UNDERTAND THAT WOLVERINE IS FIELD PAINT ONLY, AND I WILL USE ONLY PAINTBALLS PURCHASED AT WOLVERINE PAINTBALL PARK. ALCOHOLIC BEVERAGES ARE PROHIBITED
